Bovine TB cost the UK taxpayer £500 million in 2011 Scotland is Officially TB free

The Tuberculosis in Specified Animals (Scotland) Order 2015 Non-bovine TB controls extended-Notification & compulsory slaughter alpaca, llama, vicuna, guanacos, deer, sheep, goats and pigs

# **Bovine Viral Diarrho**ea (BVD)


The Bovine Viral Diarrhoea (Scotland) Order 2013 as amended **Phase 4 of the BVD eradication scheme.** 

- Mandatory annual screening
- Restrictions on BVD infected animals
- Restrictions on 'not negative' herds
- Reduction of the testing options available
- Testing (animals entering herds from untested herds)

## **Bovine Viral Diarrhoea (BVD)**

#### **Current BVD test results for Scotland**

- 83% are now 'negative' with just 17% 'not negative',
- 1750 PI animals identified, the vast majority of these are now dead.


Total number of premises by region notifying incidences of Sheep Scab during 3rd guarter2015.

## **Porcine Epidemic Diarrhoea (PED)**

- New virulent strain of PED in China, North America
- Death in 80-100 per cent of infected suckling pigs
- Affects growth rates and reproductive performance
- Similar strains are circulating in Europe
- Consultation "Unanimous"

# **Microchipping of Dogs**

- The Microchipping of Dogs (Scotland) Regulations 2016
- from 6th April 2016 every keeper of a dog which is older than 8 weeks must ensure that it is microchipped.
- every keeper of a dog which has been implanted with a compliant microchip must notify any change to the details that are to be recorded on the database
- where the dog has not been microchipped an authorised person may serve on the keeper of a dog a notice requiring the keeper to have the dog microchipped
- offence not to comply
