It will be of benefit to experienced owners, farmers, livestock hauliers, grooms, horse box drivers, stockmen and attendants as well as for the less experienced as training and guidance. The course is also relevant to all personnel involved in the livestock industry.

DT=Digital Tacho Card, PP=Passport, DQC=Driver Qualification Card, please bring your DL=Driving Licence with you.

NB. Old Style Licence must be accompanied by valid ID
